1. Purpose

- d) Such programmes will provide an opportunity to the Independent Directors to interact with the senior leadership team of the Company and help them to understand the Company's strategy, business model, operations, service and product offerings, markets, organization structure, finance, human resources, technology, quality, facilities and risk management and such other areas as may arise from time to time.
- e) Such programmes will be conducted for new and continuing Independent Directors of the Company.

2.2 Regular Updates

Independent Directors shall be provided with updates during various Board/Committee meetings on:

- macro-economic environment, Industry developments and regulatory updates, as necessary
- business overview, operations, financial statements and other material updates
- update on statutory compliances for Board members including their roles, rights & responsibilities

To ensure that Independent Directors remain updated on Company's affairs, and the industry in which Company operates, the Independent Directors of the Company shall be informed of the important developments in the Company. The Company may also circulate news and articles related to the industry and may provide specific regulatory updates from time to time.

2.3 External training programs

Independent Directors may also be offered options to attend training programs like seminars, conferences, workshops, etc., conducted by external agencies, relating to the industry/statutory and regulatory provisions.

3. Programme and disclosure:

This familiarization program shall be conducted from time to time and/or as and when need arises.

This Familiarization Program shall be uploaded on the Company's website and a web link for the same shall also be provided in the Annual Report of the Company

4. Revisions/Modifications to this Program

Any revisions/modifications to this Program shall be made by the Board of Directors from time to time.
